Motion by Mitchell, second by Derhammer to approve the agenda with the addition of **D. Generator Proposal** under New Business. All voted in favor. Motion carries.

Motion by Osborne, second by Cutting to approve minutes from November 12, 2013 as mailed. All voted in favor; Derhammer abstained. Motion carries.

New Business:

A. <u>Federal Poverty Guidelines</u>

Assessor Ben Brousseau provided the Board with the 2013 federal poverty guidelines and sample hardship application. The Township does have the ability to increase, but not lower the guidelines. Each year the Board must adopt guidelines to be used by the March Board of Review and Township Supervisor for calculating an applicant's eligibility for a poverty exemption from some or all property taxes. The application includes a Poverty Exemption Affidavit completed when the applicant is not required to file federal or state income taxes, which copies of tax returns had previously been a requirement in filing for the hardship (poverty) exemption.

Motion by Osborne, second by Cutting to adopt the federal poverty guidelines with a 20% increase. All voted in favor. Motion carries.

B. Township Board 2014 Meeting Schedule

Schedule of 2014 meetings for township board was presented. All meetings will occur on the second Tuesday of each month starting at 7:00 pm, with the exception of the September meeting which normal starting time is 6:30 pm due to special assessment hearings. June budget hearing will be determined and set at the May meeting.

Motion by Osborne, second by Derhammer to approve the 2014 Township Board meeting schedule. All voted in favor. Motion carries.

C. Public Act 161 of 2013 Advertisement

Governor Snyder recently signed into law P.A. 161 of 2013. The Act amends MCL 211.7b regarding Veterans Exemptions. Discussion on new eligibility requirements and affidavit developed by the Veterans Administration to be approved by the State Tax Commission on December 16. Board

feels an advertisement (after 12/16 STC meeting) in local papers would help to make more disabled veterans aware of new benefit.

Motion by Derhammer, second by Mitchell to publish advertisements in Courier Leader and Flashses in regards to PA 161 of 2013. All voted in favor. Motion carries.

D. <u>Generator Proposal</u>

Recently, the Township has lost power for lengths of time. Initial requests into generators for the Activity Center and Township Hall/Library have produced two bids from electrical engineers to assist us with the process. Byce & Associates provided a proposal to analyze, size, engineer, specify and documents the proposed installation of two emergency generators with automatic transfer switches in two phases. Phase 1 – Activity Center @ \$3340 and Phase 2-Township Hall/Library @ \$6150. Kingscott provided a proposal for electrical engineering services as well. Option 1-Activity Center @ \$5500 and Option 2- Township Hall/Library @ \$8500 and Option#3 for both @ \$10,000.

Motion by Derhammer, second by Osborne to accept Phase 1 proposal from Byce & Associates at \$3340. Roll Call Vote: Cutting-yes; Osborne-yes; Mitchell-yes; Derhammer-yes; Ruzick-yes. Motion carries.
