Paul Schincariol - Van Buren County Commissioner

- 1. A county wide land bank has been approved. \$5,500 was used from the general fund to seed the land. Moving forward it will be self-sustaining.
- 2. 5 single and 2 double arraignment rooms have been created that are self-contained creating privacy and safety within the courthouse.
- 3. Van Buren County Road Commissioner submitted his resignation to become the Treasurer of Almena Township. The vacancy created at the Road Commission was filled by Todd Hackenberg.

New Business:

A. Antwerp Township and Mattawan Fire update

Mattawan fire and the Township have been working with the Township attorney to complete the merger of the fire department with the quick response department. Unbeknownst to the Township, Mattawan fire obtained their own legal counsel and established an EIN and a 501(c)3. The Township attorney is working with the fire department attorney to negotiate the split of the fire department from the Township and to merge the fire and quick response. Supervisor Ruzick will work the Township attorney regarding this issue and report back to the Township Board.

B. Transfer Station update with Nu-Wool paper.

The Township is working with Nu-Wool to come to an agreement on recycling paper at the transfer station. Supervisor Ruzick will work with Nu-Wool to get a proposal for service and report back to the Township Board.

C. Antwerp Township 2021-2022 road project estimates

Road Commission provided an estimate of projects for the upcoming year. The Township Board will prioritize the projects for Supervisor Ruzick to discuss with the Road Commission.

D. Vik Bawa letter dated 1-25-2021 requesting recreational marihuana in the Township.

The Township received a letter regarding parcels located in Derhammer parkway to be used for recreational marihuana. In 2019 the Township voted to opt in to medical marihuana and ordinances were established. The Township also voted to opt out of recreational marihuana at that time. Mr. Bawa is requesting that the Township reconsider their decision to opt out of recreational. The Township Board agreed to open the discussion on recreational marihuana in the Township. We will work with our zoning and planning administrator as well at the Township attorney to gather more information about his request.

E. Zoning text amendment to allow and regulate accessory dwelling units.

Planning Commission has been working with residents regarding the usage of accessory dwelling units and feels the zoning ordinance should be amended.

Motion by Osborne, second by Stock to amend the current zoning ordinance pertaining to accessory dwelling units. Roll call vote; Osborne-yes, Cutting-yes, Stock-yes, Ruzick-yes, Reyna-yes. Motion carries.

F. Four-year election agreement with school districts within Township.

Clerk Reyna attended meetings to renew our current four-year contracts with the school districts in the Township. The contracts spell out the responsibilities of each party involved when a school election takes place. The contract begins January 2021 and ends December 2024.

Motion by Osborne, second by Cutting to authorize Clerk Reyna to sign the four-year contract. Roll call vote; Stock-yes, Ruzick-yes, Reyna-yes, Osborne-yes, Cutting-yes. Motion carries.
