Motion by Osborne, second by Reyna to accept the agenda as submitted with the addition of item M. Harwick cemetery tree removal and item N. Van Buren County Road Commission land lease. All voted in favor. Motion carries.

Action on Planning Commission Recommendations:

- A. Consideration of Special Land Use and Site Plan amendment. Charles Brandt requests an amendment to allow on-site parking for guests of Nightmare Realm for the 2024 and 2025 seasons for property located at 23492 Red Arrow Hwy, Mattawan, MI 49071 (Parcel # 80-02-001-017-02). Planning Commission recommends approval with conditions below.
 - 1. The approval of on-site parking in granted for the 2024 and 2025 seasons.
 - 2. No more than 150 tickets are sold for each half-hour block.
 - 3. Fire Department approval is secured prior to the 2024 and 2025 event seasons.
 - 4. The operation remains in continued compliance with all Road Commission requirements and conditions of approval.
 - 5. Emergency procedures shall be established to accommodate parking beyond what is available on-site in the case of unanticipated traffic generation.
 - 6. Temporary lighting shall be used to illuminate all new parking spaces. Installation of permanent lighting for the proposed permanent eastern and western parking rows is deferred until the 2026 season.
 - 7. Upon implementation of the revised stormwater management system for the site, a maintenance plan shall be executed between the township and the owner.

Motion by Ruzick, second by Cutting to approve the special land use and site plan amendment request with the conditions listed by the Planning Commission with the exception of having an administrative review after one season to determine if the traffic plan is working. There will be no additional cost to the applicant and the amendment will extend out to cover the 2025 season. Roll call vote: Ruzick-yes, Reyna-yes, Osborne-yes, Cutting-yes, Tarchala-yes. Motion carries.

B. Antwerp Township Zoning Ordinance Text amendments to Outdoor Storage displays or sales, outdoor storage and indoor vehicle sales. Planning Commission recommends approval of the text amendment.

C. Antwerp Township 2024-2025 Budget

Proposed budget was discussed at budget hearing. Brief recap includes: 3% salary increase for all Township employees and Board members excluding trustees, in lieu of insurance compensation increased to \$650 per month, health coverage will now be 100% employer paid, all representatives on Boards compensation increase to \$100 per member and \$110 for Chair and Secretary, Hall coordinator position created for hall rentals with compensation of \$400 monthly salary.

Motion by Osborne, second by Tarchala to approve the 2024-2025 budget. Roll call vote; Tarchala-yes, Ruzick-yes, Reyna-yes, Osborne-yes, Cutting-yes. Motion carries.

D. Antwerp Township and Mattawan Fire Budget adjustments

Mattawan fire presented two adjustments to be made for fiscal year ending June 30, 2024. Antwerp Township also presented two adjustments for fiscal year ending June 30, 2024.
