# MINUTES FROM THE REGULAR ANTWERP TOWNSHIP BOARD MEETING Tuesday, April 9th, 2024

Supervisor Ruzick called the meeting to order at 6:30 pm.

Pledge of Allegiance

Board Members Present: Daniel J. Ruzick-Supervisor, Chantel Reyna-Clerk, Bonnie Osborne-Treasurer, Phil Tarchala-Trustee

Board Members Absent: Bruce Cutting-Trustee

Also Present: 26 guests

Supervisor Ruzick called the public hearing to order.

 Higley's Orchard Downs Special Assessment District would allow for Higley's Orchard neighborhood to be sprayed for spongy moths. The Township received a petition with 51% or greater of property owners requesting the special assessment district be created. This is a one-year assessment.

Resident: What is the chemical being sprayed? Other residents responded with a natural bacterium that does not harm household pets.

Resident: If the district is established tonight, will this be for one year or from now on? Supervisor Ruzick stated that the special assessment is only valid for one year. If the residents would like to spray again, they would need to submit another petition with 51% or greater of the property owners' signatures.

Resident: Stated that he scrapes trees twice a day and can not continue to keep up with taping to save the trees.

Resident: This is the most cost-effective option. The cost of tree removal is expensive.

Resident: Where will the product be sprayed? Supervisor Ruzick stated that it would be sprayed in the recorded plat of Higley's Orchard Downs.

Supervisor Ruzick: Are there any residents here that are in opposition of the special assessment district? There were no residents in attendance that did not want to establish the district.

Resident: The DNR and U.S. Forestry site has information regarding the product used.

Supervisor Ruzick closed the hearing at 6:49pm.

# **Action on Planning Commission Recommendations:**

- A. Public Hearing and Consideration of a Special Land Use and Site Plan. Turf Works Supply, LLC requests special land use and site plan approval for a lawn service contractor's facility for the property located at 24876 Red Arrow Hwy, Mattawan, MI 49071 (Parcel # 80-02-002-026-00). PC recommends approval with conditions as outlined in memo dated 4/4/2024.
- The Planning Commission unanimously recommended approval of the special land use and site plan
  with the following conditions. All conditions are recommended to be satisfied prior to commencing the
  use.
  - 1. Provide a to-scale parking lot striping plan showing one accessible space and standard parking spaces of at least 9 feet in width and 18 feet in depth (at least five parking spaces).
  - 2. Secure the following approvals prior to site development and building permitting:
    - a. Road Commission (driveway permit for change of use)
    - b. Fire Department (access, maneuverability, and hazardous material storage)

Motion by Osborne, second by Tarchala to accept the recommendation of the Planning Commission for the special land use and site plan for Turf Works with the conditions listed above. All voted in favor. Motion carries.

Motion by Tarchala, second by Osborne to establish the special assessment district for Higley's Orchard Downs for one year for the treatment of spongy moths. Roll call vote; Reyna-yes, Osborne-yes, Tarchala-yes, Ruzick-yes. Motion carries.

- 3. Project 497.3179 Crack seal on 66th Ave., 29.5 Street, 23rd Street, 24th Street, 27th Street, Sunset Estates Subdivision. Antwerp Township portion only in the amount of \$72,543.15.
- 4. Project 489.3141 Tree Removal, Wedge Pave and Trap Rock Sealcoat + Fog Seal on 72<sup>nd</sup> Ave. from the Village of Lawton to the East End in the amount of \$23,4278.66.
- 5. Project 489.3140 Tree Removal and Trap Rock Sealcoat + Fog Seal on 66<sup>th</sup> Ave. from 26<sup>th</sup> Street to C.R. 657 in the amount of \$40,995.12.
