C. Discussion on 1.4 or 1.5 mills for Mattawan Fire Assessments

Township Board feels 1.4 mills should be levied in 2024. In 2025 when Almena Township increases to 1.5 mills then Antwerp will do the same. Assessment hearings will be held at the next regular scheduled Township Board meeting on September 10th, 2024.

D. Discussion on having tire collection in fall

Township board would like to move forward with a tire collection to be held in the fall.
