E. Resolution to dispose of asset Fire truck 2003 Ford F550 pumper

Mattawan Fire Department will sell its 2003 Ford F550 pumper to Arnegard Rural Fire District located in Arnegard, North Dakota in the amount of \$40,000.00.

Motion by Osborne, second by Tarchala to adopt a Resolution for the sale of the 2003 Ford F550 pumper truck in the amount of \$40,000.00. Roll call vote, Tarchala-yes, Ruzick-yes, Reyna-yes, Osborne-yes, Cutting-yes. Motion carries.

F. VBCRC Parking lot at satellite location

Clerk Reyna received four bids for the parking lot

Motion by Tarchala, second by Reyna to award the bid to Aleksich Excavating in the amount of \$349,196.20 pending review from the Engineer and bond. Roll call vote; Reyna-yes, Osborne-yes, Cutting-yes, Tarchala-yes, Ruzick-yes. Motion carries.

G. Transfer station discussion on non-resident usage

After discussion, the Board feels that the recycling portion of the transfer station should only be utilized by residents at this time. If the request for usage from non-residents increases, we will discuss that at a later time.

H. Cemetery tree removal

There are trees and branches down at the cemeteries. Supervisor Ruzick will get quotes for the removal. The Board will allow Supervisor Ruzick to work with a contractor to get them removed with the amount not to exceed \$1000.00.

Motion by Cutting, second by Osborne to authorize Supervisor Ruzick to get the trees and branches removed from the cemeteries with the amount not to exceed \$1000.00. Roll call vote; Reyna-yes, Osborne-yes, Cutting-yes, Tarchala-yes, Ruzick-yes. Motion carries.

I. Website upgrades

Clerk Reyna is working toward converting the Township website to a .gov website. While doing so, the IT company suggested a more user-friendly website upgrade. The cost would vary from \$1000 to \$1500.

Motion by Tarchala, second by Osborne to authorize Clerk Reyna up to \$1800.00 for the upgrade of the Township website. All voted in favor. Motion carries.

J. Fox Creek Street Light Special Assessment

Supervisor Ruzick received a petition with 47 signatures requesting a special assessment for streetlights. A Resolution to establish the district was presented.

Motion by Cutting, second by Osborne to adopt the Resolution for Fox Creek streetlight special assessment. All voted in favor. Motion carries.
