#### A. Mattawan Fire Position

Brief recap includes 5% salary increase for all Township employees and board members, Capital outlay added to Senior services budget to make improvements to the program as it continues to grow, budgeting done for the Township parking lot to be done and computers with the new windows 11 have been budgeted for.

#### F. Blue Cross Blue Shield Insurance Renewal

Insurance agent presented the proposal for health insurance with an 8.11% increase of premiums. The reasons stated for increases include; high cost of prescription drugs, higher utilization of behavioral health services and higher provider reimbursements.

Motion by Cutting, second by Tarchala to approve the quote presented for health insurance. Roll call vote; Tarchala-yes, Ruzick-yes, Reyna-yes, Osborne-yes, Cutting-yes. Motion carries.

#### G. Transfer Station electrical and pole setting for 2 cameras

Bids were received for electrical and the pole setting for the 2 cameras needed at the transfer station. Juriga contracting presented a quote in the amount of \$3200.00 for electrical service, Aleksich Excavating presented a quote in the amount of \$1960.00 to set two poles for the cameras and Hi-Tech Electric presented a quote in the amount of \$27,785.00 to bore for the poles and run electrical service.

Motion by Tarchala, second by Osborne to approve the two bids submitted for electrical service and poles at the transfer station for a total amount of \$5160.00 from Juriga Contracting and Aleksich Excavating. Roll vote Reynayes, Osborne-yes, Cutting-yes, Tarchala-yes., Ruzick-yes. Motion carries.

#### H. Vineyard Classic Bicycle Tour Resolution

Van Buren County Road Commission is requesting a letter of approval or Resolution for a bicycle tour that will run through Antwerp Township on September 7, 2025.

#### I. Maple Grove tree removal /fence repairs

Justice Fence provided a quote to repair fencing at Maple Grove from the recent storm in the amount of \$1380.00 and a quote to repair the fencing at the transfer station in the amount of \$1315.00. Abraham Solis submitted a bid in the amount of \$7000.00 to removal trees and stumps at Maple Grove cemetery.

Motion by Cutting, second by Osborne to accept the bids from Justice Fence and Abraham Solis to remove trees and stumps and repair all fencing damaged by storm in the amount of \$9695.00. Roll call vote; Osborne-yes, Cutting-yes, Tarchala-yes, Ruzick-yes, Reyna-yes. Motion carries.

## J. Authorization for Supervisor to dispose of 2015 F350 Ford fire truck

2015 F350 fire truck was recently struck by a tree during storm and was determined to be totaled by insurance company. The Township would like to purchase the totaled vehicle back from the insurance company and sell outright.

Motion by Tarchala, second by Cutting to purchase the truck from the insurance company and sell outright with a minimum bid of \$5500.00. Roll call vote; Ruzick-yes, Reyna-yes, Osborne-yes, Cutting-yes, Tarchala-yes. Motion carries.
