# B. Proposal for Senior Service kitchen oven closet

Supervisor Ruzick contacted three contractors and only received a bid from Hall Builders in the amount of \$10,584.00.

Motion by Cutting, second by Tarchala to accept the bid in the amount of \$10,854.00 from Hall Builders. Roll call vote; Reyna-yes, Osborne-yes, Cutting-yes, Tarchala-yes, Ruzick-yes. Motion carries.

## C. Discussion on 1.4 or 1.5 mills Mattawan Fire Assessments

Antwerp Township residents have previously paid 1.4 mills to Mattawan Fire Department. There was discussion as to whether Antwerp Township would match Almena Township at 1.5 mills. After calculating 1.4 vs 1.5 the fire department would stay within budget and still have funds to put into their sinking fund.

Motion by Cutting, second by Tarchala to set the Special Assessment millage rate for Antwerp Township at 1.4 mills. Roll call vote; Osborne-no, Cutting-yes, Tarchala-yes, Ruzick-yes, Reyna-no. Motion carries.

## D. Proposals for signage at Transfer Station

Supervisor Ruzick received two bids for additional signage at transfer station.
