- 1. Call to order-Chairman Paquin called the meeting to order at 6:30 PM.

- 5. Public Comments on Items not Scheduled for Public Hearing-none
- 6. Trail Update Discussion-Sam from Whitman Associates presented information in regards to the Antwerp Township Regional Trail. Facts about the proposed trail and time line were given out to the public and maps were provided for public viewing. Currently the Construction project is slated to start in 2027.

Comments and items of concern in regards to the trailway were noted as follows:

- 8. Zoning Discussion. Agricultural signs- David Jirousek brought to the commissioners' attention that there was a identification sign recently installed on a farm, but Table 12-4 sign requirements do not read correctly for this to happen. Therefore, it was recommended by David Jirousek to hold a Public Hearing in regards to this change in the Table 12-4 Sign Requirements. The change would allow ground and wall signs at agricultural properties to be installed in accordance with the existing numeric, dimensional and location requirements.
